PRIVACY POLICY

Please read this privacy policy carefully.

It is the stated policy of Ventura Prime FX Limited (hereafter referred to as “**Ventura Prime FX**”, “**VPFX**”, ‘**us**’, ‘**we**’ and ‘**our**’) that VPFX will act in accordance with current best practice with regard to the processing of personal data. VPFX understands the importance of maintaining the privacy of your personal information. VPFX as a company would like to assure you of our commitment to keeping it private.

In relation to your personal data, you agree that we use and rely on the data you provided us, and we and our group companies can store and process them both in physically and/or electronically. If you decide to apply to open an account with Ventura Prime FX Limited, there is certain information that we will require from you in order to do so. This information includes, but is not limited to personal details such as name, address, date of birth, contact details, employment details, assets and liabilities, payment details, including credit card, debit card and bank account details, and other necessary financial information required for Deposit and Withdrawal in client’s account.
